Fishing reports continue to be positive on area lakes. On a recent fishing trip with my grandson, Connor, we were fortunate to catch eight walleye, all within the 17-18 inch class. I hope all of you are practicing OTLPOA's recommendation to only keep 4 walleye (within the 17-18 inch class) per person. This will ensure that our lakes remain stocked, and fishing continues to be a sport we can all enjoy, now and in the future. We're cautiously optimistic that the State Legislature will reduce the fishing limits on our lakes.

Although we continue to battle the spread of invasive species in our lakes, we also continue to see many lakes that are infested. Please ensure that you drain, clean and dry your boats whenever you enter or leave the lake. I recently signed the pledge to protect Minnesota Lakes and streams. Only 313 people have taken the pledge at this point, so I encourage you to go to [www.dnr.state.mn.us/invasives/preventspread\\_watercraft.html](http://www.dnr.state.mn.us/invasives/preventspread_watercraft.html) Follow the CLEAN, DRAIN, DISPOSE steps on the website and click on TAKE THE PLEDGE.

Enjoy the beautiful days ahead! Enjoy the lakes! And, always, be safe!

### Starry Stonewort Bus Tour

The threat that starry stonewort poses to Minnesota lakes was made clear to attendees of the starry stonewort Bus Tour to Lake Koronis. The event was held on July 11, 2022. Nearly 40 lake property owners, legislators and other lake stakeholders traveled from Fergus Falls Minnesota to Lake Koronis near Wilmer Minnesota. Kevin Farnum, a Lake Koronis resident and starry stonewort control advocate provided valuable information on the noxious matting algae and gave a history of the efforts Lake Koronis have made to combat this aquatic invasive specie. James Wooton, Minnesota Aquatic Invasive Species Research Center (MAISRC) Starry Trek Detector was on board the bus to talk about the MAISRC Starry Trek program and to answer questions. The event was sponsored by the Otter Tail County Aquatic Invasive Species Task Force and the Otter Tail County Coalition Of Lake Associations.

**PRESS RELEASE****FOR IMMEDIATE RELEASE****Otter Tail County Representatives Tour Starry Stonewort Infested Lake Koronis**

July 14, 2022 – Otter Tail County, MN The Otter Tail County Aquatic Invasive Species Task Force and the Otter Tail County Coalition of Lake Associations sponsored a bus tour to Lake Koronis to view the Starry Stonewort infestation. Representatives from Otter Tail County including watercraft inspectors, county commissioners, and Aquatic Invasive Species (AIS) Specialists listened as a Lake Koronis guide discussed the ecological and economic impacts of starry stonewort on the area. The overall impact of the tour was voiced by Bill Rollie, Otter Tail County Watercraft Inspector, when he said, “We don’t need this stuff in our (Otter Tail County) lakes.”

Starry Stonewort is an invasive alga that forms dense mats on the lakebed, sometimes reaching the surface, choking out native plants, disrupting fish habitat, and interfering with navigation and recreation.

AIS Detectors James Wooton and Kevin Farnum shared the impacts of Starry Stonewort in economic terms, “We don’t want you dealing with what we are dealing with here,” Farnum said. “Management is costly and it’s constant.” Treatment could cost upward of \$100,00.00 per year for managing the algae on one lake.

The group visited three sites, the Public Water Access where starry stonewort was first discovered in 2015, a private residence, and a marina. Plant racks were thrown to collect samples where tour attendees could examine the algae up close. “See this-it pops in your hands when you squeeze it,” Spencer McGrew, Otter Tail County AIS Specialist said. “This is a key trait in getting a proper ID.”

Commissioner Lee Rogness attended the tour and shared his takeaways at the recent board meeting, “I came away from the tour with an appreciation for our AIS crew. I think we have a good handle on this and good leadership in the field. This is a reminder for us to be vigilant on AIS in our county.”

The tour concluded with McGrew providing updated information from the latest AIS research at the University of Minnesota’s Aquatic Invasive Species Research Center. “Great work is happening at the U of MN and that is where the long-term management solutions will come from for this and other AIS. We’ve seen success with algicide treatments of starry stonewort and with copper-based treatments of zebra mussel larva. Our knowledge about their biology improves every day. I wouldn’t be doing this work if I didn’t think there was light at the end of the tunnel.”

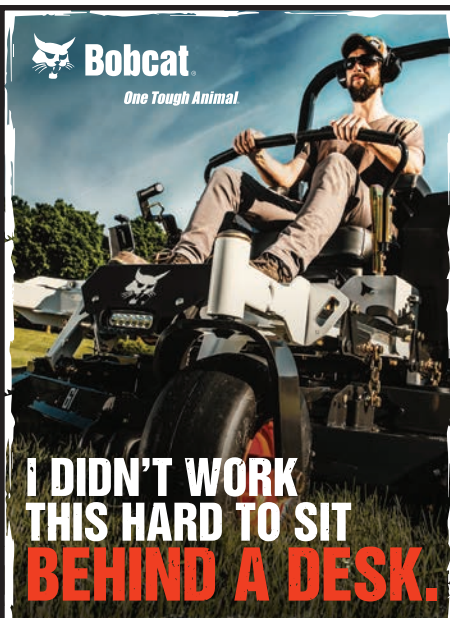

**WATER & DRINKING WATER:** Off in the campground for the season until May 13, 2022. Water is available year-round at the park office.

**BATHROOM FACILITIES:** Trail center restrooms are open year-round! Modern restroom facilities in the campground are closed for season until May 13, 2022. Vault toilets in the park are open year-round. Facilities are wheelchair accessible.

**SHOWERS:** Closed for season until May 13, 2022. Showers are wheelchair accessible.

**DUMP STATION:** None.

**CAMPGROUNDS:** Cart-in campground is open year-round. Camper Cabins and Yurts are open year-round, but just weekends between November 1 and March 31. The group camp is closed until May 13, 2022. Canoe sites are closed for season until April 29, 2022.

**ELECTRIC SITES:** One RV electric site is available after October 4 by calling the park. All camper cabins have electricity. *Special Notes for RV Campers: There is no RV camping in park in summer.*

**TRAIL NOTES:** The park has 11 miles of hiking trail, 5.2 miles of surfaced bike trail and 3.2 miles of mountain bike trails. In winter, park maintains 8 miles of groomed, easy to intermediate level cross-country ski trails. Snowshoeing is allowed alongside but not on groomed ski trails.

**SEASON RENTALS:** Bicycle, rowboat, canoe, kayak, paddleboat, and stand up paddleboard rental is open until October 25, 2021. Winter rentals (cross-country skis and snowshoes) are not available.

Nestled in the transition zone between prairie and hardwood forest, Glendalough offers a true respite from civilization. Crystal clear Annie Battle Lake is a 335-acre, non-motorized “Heritage Fishery” that provides a tranquil fishing experience second to none. Special regulations sustain a steady supply of large sunfish, crappie, and the occasional walleye for the frying pan, and large bass for the camera. Near the pristine shores of this lake are a cart-in campground and canoe-in campsites, all free from the traffic and noise of traditional drive-in camping.

Annie can also be the starting point for an exploration of the park by canoe or kayak on the connecting creeks. The restored historic Glendalough lodge on the north side of the lake details the park's history as a private retreat and game farm for the Minneapolis Tribune.

A paved bike trail loop and numerous hiking trails, including two interpretive trails, meander along five lakes, through rich woods and blooming prairies. Wildlife abounds year-round, and there are many observation decks along the trails. Trails are groomed in winter for skiing and snowshoeing. Picnicking and swimming is available on two sandy lakes.

**NATURALIST PROGRAMS & PARK TOURS:** Park shares a naturalist with Lake Carlos State Park. Call park office for more information.

**BUILDINGS & ATTRACTIONS:** Molly outdoor Picnic Shelter, historic Lodge, and Dining Hall are now available to rent and can be reserved by calling the park.

- **Spray** my equipment with high-pressure water or **rinse** it with very hot water (120 degrees for at least two minutes or 140 degrees for at least 10 seconds).
- **Dry** my boat and gear for five days before using in another water body.

## News release: DNR seeks input on proposed special fishing regulations

August 1, 2022

The Minnesota Department of Natural Resources is asking for input on several special fishing regulation proposals.

Each year, the DNR proposes new special fishing regulations that apply to individual waters and asks the public for input about the proposals. The regulations, if enacted, are reviewed on a regular basis.

The DNR is considering experimental and special fishing regulations for the 2023 fishing season that address the following topics:

**Walleye in Big Sandy Lake (Aitkin County)** — An experimental walleye harvest slot limit (14-18", 1 over 26" allowed) is expiring in 2023 and the DNR is interested in whether anglers support continuing this regulation.

**Panfish in Dyers Lake (Cook County) and Sand Lake (Lake County)** — Reduced sunfish and crappie limits have been working effectively on these lakes for a while. A proposed change would slightly modify the regulation from a reduced possession limit to a reduced daily limit. The changes would make these lakes consistent with other special sunfish and crappie regulations across the state.

**Brown trout in the Vermillion River (Dakota County)** — A proposed change would expand an existing catch-and-release-only regulation to the entire Vermillion River.

**Lake trout in Caribou Lake (Itasca County)** — A proposed experimental regulation is intended to maintain a naturally reproducing population by only allowing one fish to be kept and requiring that the fish be at least 20 inches.

**Walleye in Island and Round lakes (Itasca County)** — Highly protective slot limits have successfully built up enough large walleye in these lakes to afford some additional harvest. A proposed change would relax the protected slot to a narrower range (20-24").

**Northern pike in West Battle, Otter Tail, and Turtle River Chain of Lakes (Fergus Falls and Bemidji area lakes in Otter Tail and Beltrami counties)** — Multiple lakes have recently undergone a review of special northern pike regulations. Proposed changes include reverting to the statewide regulations for some of these lakes, while others would switch to a different special regulation and still others would retain the current slot limit.

Anyone can provide input about these proposals via an online survey that is available through Monday, Oct. 17. For additional details or to comment directly by email, U.S. mail or phone about individual proposals, contact the area fisheries office. General input may also be submitted to Jon Hansen at [jon.hansen@state.mn.us](mailto:jon.hansen@state.mn.us) (link sends email) or 651-259-5239, or via U.S. mail to Fishing regulations/Jon Hansen, Box 20, Minnesota Department of Natural Resources, 500 Lafayette Rd., St. Paul, MN 55155.

The DNR also will be hosting in-person open houses in each county where the proposed changes would apply and one in the Twin Cities metro area to cover all proposals.

For those who want to attend an in-person meeting, information can be found on the DNR website or by calling an area fisheries office. The meetings will take place on various dates between Sept. 1 and Oct. 5. The metro area open house will be from noon to 4 p.m. Wednesday, Oct. 5, at the DNR's Central Office at 500 Lafayette Road in St. Paul.

Notification of the proposed changes to special fishing regulations have been posted at the accesses to each lake included in the proposal.

## MINNESOTA PERSONAL WATERCRAFT LAWS

### You Must...

- Wear a USCG-approved life jacket. Comply with label.
- Travel at slow no-wake speed (5 mph or less) within 150 feet of: nonmotorized boats; shore (unless launching or landing skiers directly to or from open water); docks; swim rafts; swimmers; or any moored or anchored boat.
- Operate only from 9:30 a.m. to one hour before sunset.
- Use the cutoff lanyard properly.
- Obey operator age and permit laws for those younger than 18 years old.

### You Must Not...

- Chase or harass wildlife.
- Jump the wake of another boat within 150 feet of the craft.
- Operate a personal watercraft in a manner that endangers life, limb or property.

### Protect Your Sport

Respect your neighbors. Don't operate for long periods in the same area or near occupied boats or shore.

This is only a summary of the laws as of June 2018 and is required to be visible to the operator on all personal watercraft in Minnesota.

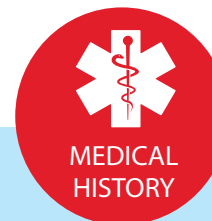


